Summary of the Newcrest Long Term Incentive Plan

The Newcrest Long Term Incentive Plan (**Plan**) provides eligible employees of Newcrest Group with an opportunity to be allocated rights to acquire fully paid ordinary shares in Newcrest (**shares**).

Each right is a right to receive a share at the end of a 3-year performance period, subject to the employee remaining employed by the Newcrest group and satisfying any applicable performance conditions.

Shares resulting from the vesting of rights may be subject to a holding lock for a period of 12 months from the vesting date.

Pro-rata vesting of rights may occur on cessation of employment in certain circumstances.

Employees will continue to participate in the Plan until they withdraw their participation, their employment ceases or the Plan is terminated by Newcrest.

The Board may exercise its discretion to allow all or some unvested rights to vest if a change of control event occurs.
